AMENDMENT TO DECLARATION OF RESIDENTIAL COVENANTS, CONDITIONS, RESTRICTIONS AND MAINTENANCE ASSOCIATION FOR PRAIRIE ROSE

THIS AMENDMENT is made by PRAIRIE ROSE WAUKEE, LLC, an Iowa limited liability company, "Declarant" of the Declaration of Residential Covenants, Conditions, Restrictions and Maintenance Association for Prairie Rose recorded August 20, 2021 in Book 2021 at Page 24472 in the records of the Recorder for Dallas County, Iowa (as amended, collectively the "Declaration").

WHEREAS, pursuant to the Declaration, Declarant has established and placed certain covenants, conditions, restrictions, reservations and easements on the following described real estate:

Lots 1-33 in Prairie Rose Plat 1; and Lots 1-36 in Prairie Rose Plat 3; and Lots 1-63 in Prairie Rose Plat 4; and Lots 1-63 in Prairie Rose Plat 5; and Lots 1-48 in Prairie Rose Plat 6, Official Plats in Waukee, Dallas County, Iowa.

WHEREAS, the Declaration grants to Declarant the right to amend the Declaration without approval or consent of any other party.

NOW, THEREFORE, pursuant to the authority described in the Declaration, Declarant hereby amends the Declaration as follows:

1. <u>Pet Restrictions</u>. Article VII, Section 3 of the Declaration relating to household and yard pets is amended to replace the sentence restricting the number and weight of dogs and cats that may be kept on a Lot with the following sentence:

In no event, however, shall the number of dogs and cats be kept at any one Lot at any one time that exceeds the number allowed under Waukee City Ordinance, which is currently restricted to no more than three (3) cats and three (3) dogs per household.

2. Ratification. Except as expressly	y amended hereby, all of the terms and conditions
of the Declaration shall continue in full force and	d effect and are hereby ratified and confirmed.
